1. The forms participating in the auction will have to submit a participation fees of Rs. 10,000/- in favour of Director, ICAR- NBAIM. The deposit should be made in form of Demand draft.
2. The participating firms will have to submit following documents-
  - i. Valid registration document of the firm.
  - ii. Prior experience of participation in government auction.
  - iii. Declaration showing that the firm is not blacklisted.
  - iv. Authorization letter to person/persons to participate on behalf of firm.
3. The person authorized by the firm should submit a valid id and address proof to participate in the auction.
4. The auction will be done on "As is where is" basis.
5. The Director NBAIM reserves the right to reject any bid during the auction.
6. The Director NBAIM has the right to reject the auction process at any stage without any assigning any reason.
7. The successful bidder will have to deposit 25% of the bidding amount in cash immediately on same day ie. 02.12.2024 remaining 75% amount will have to deposited by the next day ie. 03.12.2024. The bidder will be allowed to pick up the unserviceable/ obsolete items only after depositing 100% amount.
