TERMS AND CONDITION OF SUPPLY

- Microbial cultures under 'safe deposit' are not catalogued for public use and maintained with confidentiality. The cultures are available to the depositor/organization only or third parties with written authorization of depositor/organization.
- All orders should be addressed to Director, ICAR-National Bureau of Agriculturally Important Microorganisms, Kushmaur, Mau-275103, Uttar Pradesh, India.
- Submit duly completed passport data, relevant documents and culture(s) to NAIMCC for assigning accession number to culture under safe deposit.
- All payments should be made in advance by demand draft (DD) drawn in favour of 'ICAR UNIT, NBAIM, Mau Nath Bhanjan, U.P.' for the specified amount. You may also transfer amount online to Bank - **State Bank of India**; Bank account – **11143371878**; IFSC code number - **SBIN0001671** with intimation to Director, ICAR-NBAIM furnishing details of transfer. (TAN No. of NBAIM is **ALDN00473E** & PAN No. of ICAR is **AAAA11830P**)
- Maintenance fee once paid is non-refundable.
- For extension of safe deposit contract for next specific period, the depositor/organization will be contacted by In-charge, NAIMCC, ICAR-NBAIM, Mau one month before date of expiry.
- In case of discontinuation of maintenance fee, ICAR-NBAIM will have sovereign rights over the culture(s) for use in research and other activities in the interest of nation.
