2. The tenders are liable to be ignored if complete information as required is not given therein or if the particular asked for in the schedules to the tenders is not fully filled.
3. 11. Non-compliance of any of the Terms & Conditions of the tender shall make the Bid liable to be rejected, calling for no exception/further request in this regard.
12. **Dispute Resolution Mechanism:** if any dispute or difference arises between the agencies/firm and ICAR-NBAIM, Mau relating to any matter connected with the contract, the parties shall make every effort to resolve the same amicably by mutual discussions. However, if the parties fail to resolve the dispute or difference by such mutual discussion within 30 days, either the purchaser or the supplier may give notice to the other party of its intention to refer the same to arbitration. The arbitration shall commence thereafter. 13. 5 %of total cost as a Security deposit for the Contract in the form of D.D is to be deposited by the selected agency/successful tenderer only after receiving a communication from the institute. In the event of non-deposition of the same, the earnest money will be forfeited. If during the validity of the Contact, the tenderer expresses his inability to continue with the quoted rates or asks for enhancement, the security deposit shall be forfeited and no request in this regard shall be considered.
